# ADDENDUM TO P-TECH MEMORANDUM OF UNDERSTANDING BETWEEN

## CONSTRUCTION SCIENCE P-TECH AT SIDNEY LANIER HIGH SCHOOL SAN ANTONIO INDEPENDENT SCHOOL DISTRICT

#### **AND**

#### ST. PHILIP'S COLLEGE ALAMO COLLEGES DISTRICT

This Addendum amends the 2021-2022 Early College High School Memorandum of Understanding (herein referred to as "MOU") between ST. PHILIP'S COLLEGE (herein referred to as "the College"), a college of the ALAMO COMMUNITY COLLEGE DISTRICT (herein referred to as "Alamo Colleges District"), and the San Antonio Independent School District (herein referred to as the "School District"), a Texas Independent School District contracting on behalf of its **CONSTRUCTION SCIENCE P-TECH AT SIDNEY LANIER HIGH SCHOOL** (herein referred to as the "P-TECH," and collectively referred to as "Parties") effective August 1, 2022. The Parties enter into this Addendum under the general provisions of the Interlocal Cooperation Act, Texas Government Code Chapter 791.

This Addendum shall amend the MOU, and the provisions of this Addendum shall prevail over any conflicting provisions of the MOU.

The Term of the MOU is hereby extended through November 30, 2022, to allow Parties sufficient time to negotiate changes to the Alamo Colleges District form of 2022-2023 Pathways in Technology Early College High School Memorandum of Understanding proposed by the School District.
