- I. Course Description: Basic study of the human form and conceptual aspects of drawing.
- II. Prerequisites, Corequisites, and Other Requirements: Prerequisite - ARTS 1317. Other Requirements - Materials Required: Newsprint drawing pad (24"X36"), illustration board, variety of charcoal and graphite pencils, graphite sticks, conte crayon, charcoal (vine and compressed), watercolor brushes, india ink, felt tip pens, crayons, pastels (oil and dry), erasers, masking tape, metal ruler, bulldog clamps, materials box. See 'Instructor Requirements' section of this syllabus for specific materials list and/or requirements.
- III. Textbook: Required. *Drawing, A Contemporary Approach* by Betti and Sale
- IV. Methods of Instruction:
- A. Learning is primarily gained from direct, observable work experience in the classroom.
 - B. Reading assignments from text and supplemental material is also required.
 - C. A lecture including visual examples will introduce each project assignment.
 - D. Individual and group assistance is provided during classroom drawing time.
 - E. Discussions and critiques encourage individual verbal participation and self evaluation.
 - F. Visits to area museums and galleries including the VAT department gallery will supplement classroom experience.
- V. Course Content:
- A. Drawing strategies emphasize conceptual issues and processes found in modernist and some post-modernist art.
 - B. Plastic manipulation of media as drawing stimulus, conveyor of expression, and as poetic content.
 - C. Drawing experiments with the picture plane as the spatial common denominator for both fixed observer (Renaissance) spatial compositions, and (Modern) divided and asserted picture plane strategies.
 - D. Symbiotic relationship explored between development of visual acuity and formal visual language acquisition with emphasis on the perceptual.
 - E. Terminology and vocabulary development relevant to becoming visually literate.
 - F. Critical thinking strategies for analyzing works of art history and evaluating drawings done in the classroom.
- VI. Student Learning Outcomes:
- A. The student will be able to synthesize the formal issues of drawing by composing experimental, hands-on plastic works for presentation.
 - B. The student will be able to analyze and explicate their own works, the drawings of classmates, and contemporary and historical examples in area museums and galleries, both verbally and in written form.
 - C. The student will be able to demonstrate self-discipline within the group studio environment in order to produce unique works with the appropriate use of tools and facilities.
 - D. The student will be able to define visual art terms in the final written exam.
- VII. Course Requirements and Grade Computation:
- A. College Requirements: A written, comprehensive final examination, not to exceed two and one-half hours in length, shall be given at the end of each semester for each course at a regularly scheduled time. Any exceptions to these requirements must be approved by the appropriate dean. Other examinations are given at the discretion of the instructor. A student who must be absent from a final examination should petition that instructor for permission to postpone the examination. A student absent without permission from a final examination is graded "F". Postponed examinations result in a grade of "I". The final exam must be taken within 120 calendar days from the end of the semester or the grade automatically becomes an "F". (San Antonio College Bulletin, Faculty Handbook - Jan. 1995) (For additional information regarding grade computation, refer to Instructor Requirements.)
 - B. Department Requirements:
 - 1. Students must abide by all posted rules and established procedures for studio, equipment, and computer use.
 - 2. Students must participate in safety instruction provided by the department before using shop tools.
 - 3. Students are not allowed to bring food or drink into the studios/classrooms.
 - 4. Students must observe proper gallery etiquette by not touching or leaning on artworks or sculpture pedestals.
 - 5. Students must clean up work area before leaving.
 - 6. Students must use ventilated spray booth in Rm. 216 for any aerosol spraying of paints, fixatives, or adhesives.
