

CARES Act Higher Education Emergency Relief Fund (HEERF) I, II, and III Report St. Philip's College October 2021 – December 2021

The CARES Act Higher Education Emergency Relief Fund-IHE/Student Aid provides funding to institutions to provide emergency financial aid grants to students whose lives have been disrupted, many of whom are facing financial challenges and struggling to make ends meet. Students cannot apply for assistance directly from the U.S. Department of Education but should contact their institutions for further information and guidance. Institutions have the responsibility of determining how grants will be distributed to students, how the amount of each student grant is calculated, and the development of any instructions or directions that are provided to students about the grant. Accordingly, the following information regarding the institution's allocation under CARES 18004(a)(1) must appear in a format and location that is easily accessible to the public 30 days after the date when the institution received its allocation and updated every 45 days thereafter. Further, the following information regarding the institution's allocation under CRRSAA (a)(4) and ARP (a)(4) reported quarterly and posted on the institution's website 10 days after the end of the quarter:

1. An acknowledgement that the institution signed and returned to the Department the Certification and Agreement and the assurance that the institution has used, or intends to use, no less than 50 percent of the funds received under Section 18004 (a)(1) of the CARES Act to provide Emergency Financial Aid Grants to students.

6. The Consolidated Appropriations Act, 2021 included additional COVID-19 relief through the Coronavirus Response and Relief Supplemental Appropriations (CRRSA) Act. CRRSAA (also called HEERF II) provided Alamo Colleges District (ACD; also called HEERF II) with \$54,869,824 in (for student and institution) and the American Rescue Plan (ARP) provided ACD with an additional \$50,296,197 in student funding using the

same Higher Education Emergency Relief Fund (HEERF) model established in the Coronavirus Aid, Relief and Economic Security (CARES) Act.

In addition to an increase in funding, there were a number of rule changes. The most significant to ACD awarding are:

- Use of funds: Awards may be used for any component of the cost of attendance (COA) and emergency costs that arise from the pandemic, including tuition, food, health & child care. In addition, CRRSAA requires that institutions prioritize awarding students with “exceptional need”. Although ED gives an example of “exceptional need” as Pell Grant eligible, the definition and target population is left to the institution as long as it is thoroughly documented as policy.
- Title IV Eligibility: ED has removed TIV eligibility as a requirement, but maintains a student must be a citizen or eligible non-citizen. Many institutions report (to NASFAA) that they will continue to require FAFSA for proof/record of citizenship. At the time of writing ED has not issued written guidance on the eligibility of undocumented, DACA and international students for HEERF II & III funds.
- Distance education: Students enrolled exclusively in distance education courses are eligible for awards under HEERF II & III.
- Student portion of allocation: Institutions are required to award the same amount in HEERF II funds (minimum) as required to award in the initial CARES Act allocation, eliminating the percentage of total allocation formula.

Awarding Philosophy

A national survey conducted by NASFAA reports that a large number of institutions (state and national) plan to award HEERF II funds using a similar (hybrid) philosophy as ACD adopted for initial CARES: 1) batch awarding to specific population, and 2) student application. Justification of batch awarding is twofold:

general acceptance that all students were (in some way) affected by the pandemic, and; ED's narrow disbursement window (timeframe).

Assumptions (Recommended)

1. Exceptional need: Pell Grant eligible (EFC < 5712)
2. Eligible citizen: As reported/confirmed by ED (FAFSA)
3. Funds: ACD utilizes funds for both batch and individual (application) awarding Models

Two formulas were used to identify batch award amounts:

1. Percentage of funds: Taking a specific percentage of each college's allocation and dividing equally among the number of Pell Grant eligible students enrolled during the spring 2021 semester (202120) on February 2, 2021. Breakdowns were analyzed at 100%, 75%, 67% and 50%.
2. Standard award amount: Taking a standard award amount per student for all colleges and dividing equally among the number of Pell Grant eligible students during same time period as above. Breakdowns included awards of \$500 through \$1,000.

Breakdown of the award amounts calculated from the formulas 1&2 were analyzed using multiple disbursements (1-5) spanning spring, summer and fall. Projections did not assume non-enrollment or a transfer/change of homeschoools for disbursements three through five.

Percentage of funds (formula 1) was ruled out for multiple reasons, specifically related to the significant difference in award amounts (given the range of allocations per college and number of Pell eligible students) between colleges and possible issues involving homeschool transfers and general public relations. Standard award amount (formula 2) assumes a set (same) amount to be awarded to each Pell eligible student regardless of homeschool and tables include the total amount remaining to be used for student applications.

In order to assist all students who are eligible to receive funds under the various federal emergency aid packages provided to us, the Alamo College District leadership made the decision to act and provide a one-time payment all Pell Grant students enrolled for the Fall 2021 semester.

Eligible students who do not receive aid under this distribution of one-time payments (see [Fall 2021 Distribution](#) below), could submit an application for Federal Emergency Aid. The Higher Education Emergency Relief Grants under all federal aid programs are based on emergency costs that arise due to the coronavirus. The funding is not tied to existing financial aid programs such as Pell Grants and can be used by students for any component of the cost of attendance at the colleges. Student eligibility requirements for all Federal Emergency Aid are based on guidance and criteria provided by the U.S. Department of Education.

Recommendation

One (1) standard award of \$500-700 would be impactful and "significant" to offset costs/expenses related to the COVID-19 pandemic, deter issues arising from different award amounts per college across the District and allow all colleges to retain substantial amounts which could be dedicated to individual students submitting applications.

Fall 2021 Distribution

The amount initially distributed to students in Fall 2021:

\$200- One-time payment to all students registered for classes in Fall 2021

The amounts additionally distributed to Pell grant students in Fall 2021:

\$600 - Students considered as “dependent” based on information submitted on their FAFSA

\$1,000 – Students considered “independent” based on information submitted on their FAFSA

\$2,000 – Student considered “independent” who have dependents

The status is determined based on responses the student provides on their FAFSA the day it is completed.

Notes

- Amounts used in the projections/analysis are the minimum which ED requires each college to use for student awarding.
- Dollar amounts and percentages related to remaining funds noted in charts are date sensitive. The number of Pell eligible students increase as ISIRs are processed and determine eligibility (number of students increases as FAFSAs are received).
- All remaining unused (not disbursed) CARES (HEERF) funds were awarded under “new” rules applied to the CRRSAA HEERF II and ARP HEERF III funds.
- If HEERFII or HEERF III funds are credited to institutional tuition and fees:
 - Student’s signed acknowledgement allowing institution to do so is required. (Option to allow was added to the HEERFII & III application.)
 - Only those charges related to terms after December 27, 2020 (date of CRRSAA enactment) may be credited.
- ACD has one year from the date the supplemental funds were processed to disburse all funds. Initial drawdown must happen within ninety (90) days of G5 post
- Based on conversations between NASFAA and ED, HEERFII & III funds will not be considered estimated financial assistance (EFA), therefore not affecting a student’s federal and state financial aid package.
- Institutions may not use HEERF II & III funds that would in any way imply or require students to enroll.
