The Trustees approved travel expenses for Trustees to attend the 2019 Aspen Prize for Community College Excellence Top 10 Finalists Recognition and Winner Announcement on April 2, 2019 in Washington, D.C.

Ratifying the Purchase of Information Technology Skills Training in Accordance with the America's Promise Driven Grant Program

The Board ratified the execution of an agreement with Codeup.com, LLC of San Antonio in the estimated annual amount of \$240,000 for the purchase of Information Technology Skills Training in support of America's Promise Driven Grant Program that is funded by the U.S. Department of Labor, and authorizing renewal of the agreement for successive grant years in the amounts to be authorized by the grantor, as requested by the office of the Vice Chancellor for Economic & Workforce Development.

Purchase of Information Technology Skills Training in Accordance with a Texas Workforce Commission – Skills Development Fund Grant Award The Trustees awarded contracts to EdgeCloud Inc. estimated annual amount of \$195,000, and Rackspace US, Inc. in the estimated amount of \$275,000 for the purchase of Information Technology Skills Training in support of the Texas Workforce Commission, and authorizing renewal of the agreement for successive grant years in the amount to be authorized by the grantor, as requested by the office of the Vice Chancellor for Economic & Workforce Development.

Annual Review of the Audit Committee Charter

The Board approved the Audit Committee Charter, effective as of January 22, 2019. Annually, the Audit, Budget, and Finance Committee must review and assess the adequacy of its charter, and provide its approval of the charter. The independent assessor who performed the 2018 Quality Assessment of the Internal Audit Department recommended that the references to the Committee's functional oversight of the Internal Audit Department in the Audit Committee Charter and the Internal Audit Charter be consistent and in line with the new *Standards* of the International Professional Practices Framework by the Institute of Internal Auditors. Changes to the Audit Committee Charter have been proposed by Internal Audit to address the recommendations provided by the independent assessor. An annual review and any updates to the Charter require Board approval.

Annual Review of the Internal Audit Charter

The Trustees approved the Internal Audit Charter, effective as of January 22, 2019. Professional practice standards require an annual review of the Internal Audit Charter. The independent assessor who performed the 2018 Quality Assessment of the Internal Audit Department recommended that the Internal Audit Charter be modified to be consistent with the new *Standards* of the International Professional Practices Framework by the Institute of Internal Auditors. Internal Audit has proposed an entirely new Internal Audit Charter that is based on the new "Model Internal Audit Activity Charter" which is new authoritative guidance provided by the Institute of Internal Auditors which is in conformance with the *Standards*. An annual review and any updates to the charter require Board approval.

Audit Services Policy C.1.2 and Internal Audit Protocol C.1.2.1

The Trustees approved the policies and procedures related to audit service for periodic review and approval. The Audit Services Policy (C.1.2) pertains to both external audit and internal audit. The Audit Services Policy was last reviewed or amended on January 23, 2018. The Internal Audit Department has recommended minor changes to the Audit Services Policy. The Internal Audit Protocol (C.1.2.1) was last reviewed or amended on January 23, 2018. No changes are recommended by the Internal Audit Department to the Internal Audit Protocol. It is proposed that the Audit Services Policy and the Internal Audit Protocol be reviewed and approved by the Board.
