The institution is closing the Level 1 Certificate program in Microsoft Office Specialist (MOS) at the off-campus instructional site. The instructor teaching courses for the MOS program resigned in spring 2019, and while the high school actively sought a replacement instructor, it was unable to find a qualified individual to teach the program, precipitating the program's closure. Dual-credit welding courses will continue to be offered at the site.

Students were enrolled in the program in spring 2019, and no new students enrolled in the program in fall 2019. The institution is reminded when it closes a program or instructional site, it has an affirmative obligation to seek closure approval from SACSCOC at the time the closure decision is made. The closure date is the date students are no longer admitted.

Parents/students were informed the program was no longer an option for college credit courses when the program was removed from high school course selection sheets. Students have other opportunities for dual-credit courses with another college and in the active welding program offered in partnership with St. Philip's College. There is no cost to dual-credit students.

All instructors acting as St. Philip's College adjunct instructors had the opportunity to continue as adjuncts with the college if they wished to do so. The school staff at Bandera High School are still employed at the school.
