Background:

The work of San Antonio College is largely supported by a committee structure. Faculty, staff, students, and administrators serve on both standing and ad hoc committees. There is no common college calendar for organizing committee scheduling, however. Committee meetings are scheduled without the knowledge of overlapping meetings, often resulting in committee members not being able to participate or contribute to the committees to which they are assigned.

The SAC Faculty Senate is currently working to promote equity in committee service across the college faculty. It is extremely difficult for faculty to commit to committee service, working around teaching schedules, without knowing when committees regularly meet.

Research Conducted by Senate:

Senate members have received numerous complaints from faculty and department chairpersons regarding the lack of a common calendar for scheduling standing committee meetings.

Senate officers have discussed possibility of creating a common college calendar with Dr. Vela and Dr. Blackwood and have received positive feedback.

1. Charge and Work Products

Faculty Senate requests CET approval for the creation of a common college calendar that will be viewable by all SAC employees and students. At a minimum, consider including the following information:

Date / Time / Location of recurring meetings

Committee contact person

Faculty Senate requests CET develop a process for updating and maintaining a common college calendar and designate a person of primary responsibility.



2. Known Constraints, Criteria, or Design Principles

Use existing scheduling processes, such as Microsoft Outlook.

3. Relevant Strategic Objectives

A common college calendar is essential for SAC employees to support all work being done to achieve the four SAC Strategic Priorities.

5. Internal Stakeholders or Constituents

All administrators, faculty, and staff at San Antonio College. SAC students serving on standing committees.


