Recap – 2019-2020 Mid-Year – SPRING 2020

Entity strategic plans for the 2019-2020 Plan Year, of the <u>San Antonio College 2019-2022 Strategic Plan</u> were documented during SAC Scores SPRING 2020. In the process of documenting entity strategic plans, a review of the mission statement, goals, objectives, measures, and targets, was to occur. Mid-year findings, and action plans – if necessary, were documented or created respectively. In addition, Mid-Year Analysis Questions were to be answered and a total of two files uploaded for Strategic Planning to the SAC Scores Upload Site.

Refer to <u>Strategic Planning Terms</u> for a review of mission statement, goals, objectives, measures, targets, findings/analysis, action plans, and analysis questions.

During SUMMER 2020, utilizing a rubric, 2019-2020 Mid-Year Strategic Plans for 12 entities were reviewed by several Strategic Quality Enhancement Committee, SQEC, voting members. The review, one form of continuous improvement, provides feedback to the entities whose strategic plan was reviewed and serves to help strengthen the strategic planning process.

Review and Analysis

For the 2019-2020 Plan Year, with a year-end perspective, entities will update Entity Strategic Plans using available relevant data and analysis results. Determining which initiatives are to continue in the 2020-2021 Plan Year, will also occur.

1. Obtain a Copy of the SPRING 2020 Entity Strategic Plan

Use the SPRING 2020 Entity Strategic Plan as a reference for the year-end review and analysis process. If a copy of the entity strategic plan is not available on the device (desktop, laptop, etc.) currently being used either download a copy or request a copy by email.

If requesting a copy of the SPRING 2020 Entity Strategic Plan via email, include the name of the entity strategic plan being requested and the name of the individual who uploaded the entity strategic plan. Ensure each entity member has access to the entity strategic plan.

2. Obtain Data Relevant to the Entity Strategic Plan

Based on the SPRING 2020 Entity Strategic Plan, obtain data relevant to the entity strategic plan. Ensure each entity member has access to the data relevant to the entity strategic plan.

3. Collaborative Data Review and Reflective Analysis

Have a meeting, ensure each entity member is invited, to review relevant data for each Objective-Measure-Target in the entity strategic plan and have a reflective analysis with a year-end perspective. Review and analyze the results. What do the results reveal? Discuss the following or similar questions.

- What do the results mean for the entity?
- What did the entity learn?
- Did the entity meet the target or not?
- Why did the entity reach, or not reach, the target?
- What strength does the data reflect relative to the entity or its operations?
- How can identified strengths, be further strengthened?
- In terms of strategies,
 - Which were successful?
 - Which were not successful?
 - What strategies will be utilized to improve outcomes?
- Based on the results, what area(s) are excelling?
- Based on the results, what area(s) need attention to correct problems/issues?
- What highlights or challenges did the entity encounter?

Document Results

With the data review and analysis completed – proceed to <u>document results for each Measure-Objective-Target in the 2019-2020 Entity Strategic Plan</u>. This includes a Finding for each Measure-Objective-Target, determining the Target status, creating or editing Action Plan(s) if necessary, and answering Year-End Analysis Questions. With the exception of the Year-End Analysis Questions, which are in a separate file, <u>document 2019-2020 Year-End results in the Strategic Planning</u> <u>Template</u>. Red text and red boxes in the template indicate a field, enter text or click a box, as applicable.

4. Finding(s)/Analysis

Document results of the entity strategic plan data review for each Objective-Measure-Target. Report the results – the actual, or achieved, in comparison to the established target. If data is not available or if work on the initiative has not begun, indicate that status. In addition, include results of the questions discussed. This is where the narrative, behind the data, factors in.

5. Target Status and Action Plan(s)

Select the status, best indicating the Target's 2019-2020 Year-End state, and determine the step to follow regarding Action Plans. If a Target Status is *Not Reported This Cycle*, provide a summary in the Finding field – for instance, data is not available or work on the initiative has not begun
