

Hazlewood Exemption Required Document Checklist

Students must request certification of benefits with the SAC-VA Office each semester prior to payment deadline to prevent being purged from classes for non-payment. Per state law, Hazlewood must be submitted no later than last day of term to be authorized.

All students must provide a copy of a valid photo ID ** denotes document required every semester
