Evolution of QEP Topic

- Spring 2013 12 key issues emerged from a review of best practices and SPC need.
- Input gathered using the QEP Topic Survey.
- Student input gathered through student organizations.
- Personal Responsibility final broad topic area identified at Good to Great Retreat, May 2013.
- Initial QEP team conducted research around this broad topic area.



QEP Development

October 2014 feedback from QEP experts. <u>Narrow</u> topic focus - Personal Responsibility too broad.

Broaden base of involvement in the QEP process.


Norris Technical Building Renovation Rendering







Miss Artemisia Bowden, a graduate of the Normal Department of 1900, is principal of St. Philip's Normal and Industrial School for Girls at San Antonio, Tex. "The school in which I am now principal started from a small sewing-class of fourteen, and has now grown to be one of the largest and most influential schools in the city. We have outgrown our present location and have purchased a beautiful site of several acres in the most delightful section of the city. Cost and proposed improvement will exceed \$30,000."




