



St. Philip's College Dual Credit 2021 – 2022 Apply Texas Steps

Create an Account

1. <https://www.applytexas.org>
2. Complete all items in the My Profile tab
3. Ensure to select SAVE PROFILE when done
4. Your email is your Username – Check your email immediately as you MUST verify email.
5. PLEASE Write or Photograph Apply Texas:
 - Application ID: Located in the middle of the screen.
 - User Name: Located on the upper left side of the screen.
 - Password: The password you just created.



Note: You will receive an automated e-mail from Apply Texas titled “Your Apply Texas Profile.”

This e-mail will be sent to the email address you enter on your profile. This email is **NOT** verification that the application has been completed or submitted.

2. Create a new 2 year college admissions application

Question 3a - If your parents/legal guardian have always lived in Texas,
Years/ Months: estimate their age and enter as answer

Question 3b - If your parents/legal guardian have always lived in Texas, select **ESTABLISH/MAINTAIN A HOME** as answer.

- **Go to College** - Your parent is only temporarily living in Texas to attend college and will be moving back out of state.
- **Establish/Maintain a home - Your parent lives in Texas and has established a permanent residence.**
- **Work Assignment** - Your parent is only temporarily living in Texas for a work assignment and will be moving back out of state.

Questions 4a and b, If your parent or legal guardian is a member of the U.S. military:

- NOT a dependent Answer Reset answer – Not Applicable
- If you are a dependent, please answer the questions correctly to reflect the true Home of Record.

Questions 5a and b are seeking whether or not your parent/legal guardian own their home/property and/or a business in Texas. Answer to the best of your knowledge if your parents/legal guardian are not with you.

Question 6a reference of "**gainfully employed**" is seeking whether or not your parents/legal guardian has worked or is currently working in Texas.

- Answer to the best of your knowledge if your parents/legal guardian are not with you.

Question 6b for example: Does your parent receive government assistance such as disability checks or food stamps?

- Answer to the best of your knowledge if your parents/legal guardian are not with you.

Question 7 Are your parents married? **Yes** or **No**?

- Answer **NO**: If you answered No, skip a. and b.
- Answer **YES**: a. select Gainfully Employed from the drop down menu if one of your parents has a job in Texas. and b. How many years have your parents been married? This is just an estimate. If your parents have been married all of your life, enter your age for the answer to this question.
